

In Yan Teopa 10 Mile Trail Run

A 10 mile trail run entirely within Frontenac State Park. Runners will start and finish near the shelter in the picnic area and follow trails along the tops of the river bluffs as well as the prairies in the river bottoms. There will be 3 aid stations with water during the race with additional refreshments at the finish. Frontenac State Park is located approximately 10 miles SE of Red Wing or 5 miles NW of Lake City on Highway 61, then 1 mile north on County Road 2 This race is part of the 2011 UMTR Trail Running Series.

I understand that bicycles, skateboards, baby joggers, roller skates or blades, animals, and radio headsets are not allowed in the race and I will abide by this guideline. Having read this waiver and knowing these facts and in consideration of your accepting my entry, I, for myself and anyone entitled to act on my behalf, waive and release Superior Trail Marathons, The Department of Natural Resources, Frontenac State Park and all sponsors, their representatives and successors from all claims or liabilities of any kind arising out of my participation in this event, even though that liability may arise out of negligence or carelessness on the part of the persons named in this waiver.
